Maximum Age at Loan Maturity: 64 years

Nationality: Lebanese

- Employed Applicant: Minimum 1.5 years of employment

Loan Details

Minimum Loan Amount: USD 5,000

Maximum Loan Amount: Up to USD 30,000

Minimum Loan Term: 12 months

Maximum Loan Term: Up to 48 months

Minimum Down Payment: 40% of the vehicle purchase price for new and used cars (excluding registration fees)

Private vehicles only

- Late interest applies on overdue amounts after the installment due date until full payment.
- Minimum charge of USD 1 per overdue day.
