These Website Terms of Use ("**Terms**") govern your access to and use of the O FINANCE SAL (**O Finance**) website (the "**Website**"). By accessing the Website, you agree to be bound by these Terms.

In these Terms, any reference to "you" or "your" and other wording referring to you is a reference to you as user of O Finance Website; the reference to "we", "us", or "our" or other wording referring to us is a reference to us as O Finance.

1. About Us

O Finance SAL is a category A Lebanese finance company, registered under Commercial Register No. 71506 – Beirut, and licensed as a Finance Company No. 48 by the Banque du Liban (**BDL**) pursuant to BDL Decision No. 9701 dated 18/09/2007.

2. Scope

These Terms govern only access to and use of the Website and do not govern, amend, replace or override any separate agreement, product terms, financing agreement, application form, disclosure, consent, policy, approval letter, repayment arrangement, or any other contractual documentation issued by O Finance in relation to any product or service. In the event of any inconsistency, such separate documentation shall prevail to the extent of that inconsistency.

O Finance may, to the extent permitted by applicable law, monitor, review, record, retain, and disclose information relating to your access to and use of the Website for security, fraud prevention, compliance, audit, legal, regulatory, operational, evidentiary, or enforcement purposes. Nothing in these Terms limits O Finance's right to cooperate with regulators, courts, law enforcement authorities, or other competent authorities.

3. Eligibility & Acceptable Use

You may use the Website only if you are at least eighteen (18) years old, legally capable of entering into binding obligations, and not prohibited from accessing or using the Website under any applicable law, regulation, sanction, embargo, or restriction.

You shall not, and shall not attempt to

- (a) use the Website for any unlawful, fraudulent, misleading, abusive, defamatory, harmful, or unauthorized purpose;
- (b) access data not intended for you or gain unauthorized access to any account, server, system, database, network, or environment connected to the Website;

If any provision of these Terms is held invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid, illegal, or unenforceable provision shall be deemed modified to the minimum extent necessary to make it valid and enforceable while preserving its intent as far as possible.

15. Entire Agreement

These Terms, together with any policies expressly incorporated by reference, constitute the entire agreement between you and O Finance in relation to the Website and supersede all prior statements, understandings, and communications relating to the same subject matter

16. Governing Law & Jurisdiction

These Terms and any non-contractual obligations arising out of or in connection with them or the Website shall be governed by the laws of the Republic of Lebanon, and any disputes shall fall under the exclusive jurisdiction of the courts of Beirut, Lebanon.
